**NOTICE OF RACE**

**RULES:** The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS), except as any of these are altered by the Sailing Instructions, the Melges 24 & 32 class rules, and by the Sailing Instructions.

**ELIGIBILITY AND ENTRY:** Invited fleets are Melges 24 and Melges 32's that are members of the Melges Fleet Association. 2007 class membership dues must be paid in full in order to compete. See the class website <http://www.melges.com> for details on how to pay your dues.

Eligible boats may enter by completing the attached form and sending it to the Race Organizers by September 6, 2007. **FEES:** Entry fee is \$40.00. A late fee of \$15 will be applied to entries received after September 1, 2007.

**SCHEDULE:** Three (3) races are scheduled each day. Racing will commence at 10:00 am Saturday and Sunday. Condition permitting

All competitors and their guests are invited to attend socials at TYC after days racing. There will be a no host bar and a BBQ dinner that can be purchased Saturday evening.

**RACING AREA:** Racing will take place off the shores of the Tiburon Yacht Club East of Paradise Cay.

**SCORING:** The Low Point Scoring System, Appendix A of the Racing Rules, will apply. Three races will constitute a series. All race scores will count towards the final score (no throw-outs).
